- **Bug Repellent/Sunscreen Acknowledgement** – DCF recommends that children have on bug repellent when playing outside, because of the concern for the West Nile Virus that can be carried by mosquitoes. We encourage you to apply bug repellent and sunscreen on your child before they come to school. We do not put bug repellent or sunscreen on children at school. It is important to use a UVB/UVA sunscreen with SPF 15 or higher to protect your child.
- **Animal Notice** - DCF requires we inform you of any animals at WLPS. We have fish, frogs, toads in aquariums/terrariums, and the occasional insect in or screened box or jar. These living things are important parts of our Florida and Environmental units. We know, too, these animals have a calming effect on our children and help to teach them to look at detail.
- **Field Trip Permission** – DCF requires signed forms for any venture outside our fence. This includes walks around campus, visits to the library and any other “field trips”. All of our adventures will be on the Jacksonville University campus (no transporting of children).
- **No Smoking** – Smoking, including e-cigarettes, is prohibited on the premises of WLPS. Jacksonville University promotes a smoke-free academic environment both within buildings and along campus pathways.
- **Party Food Permission** – DCF requires parent permission for children to eat food that may not be on the regular snack menu, but that may be served at holiday parties (inc. Halloween, Thanksgiving, Christmas, Valentine’s Day, Easter, and the Leaving Ceremony), food grown in the WLPS garden, food involved in learning activities, and birthday celebrations.
